



NOTICE TO CARRIERS AND LICENSEES

Re.: COVID-19 RELIEF

APD Limited is committed to assisting the Bahamian public and the commercial shipping companies during this time where the COVID-19 virus has created uncertain conditions for the country at large.


We have therefore provided the below concessions in an effort to provide relief to the community:

1. As of Monday 23rd March, 2020, free time Storage will be increased by 14 days, thereby increasing free storage time from 10 days to 24 days (note this will only apply to FCL containers and vehicles arriving at the Nassau Container Port on the 23rd March, 2020). This will remain in effect for 30 days;
2. Rents/Lease payments will be waived for all tenants of APD Limited at our Gladstone Road Facility for the month of April, 2020; and
3. All Port Rates will be reduced by 50% with effect from Monday 23rd March 2020 for a period of 30 days from the date thereof.

The expectation is that the reduction in tariff rates are passed on to the importers and ideally consumers.
